### **HOW TO JOIN LEGACY OF HOPE**

#### **Create a Legacy Through Your Will**

There are many ways to name Cancer Support Community Valley/Ventura/Santa Barbara in your will. Your attorney may wish to use the following language.

A residuary bequest: You can give all or part of the property remaining in your estate after debts, expenses, and specific bequests are paid. Such provisions can be made as follows: "I give, bequeath, and devise (all, or \_\_\_\_\_ percent of) the rest, residue, and remainder of the property, both real and personal, wherever situated, which I may own or be entitled to at my death, to Cancer Support Community Valley/Ventura/Santa Barbara or its successor, now or formerly in the State of California, to be used for its general purposes."

A specific bequest: You can establish a bequest of a particular dollar amount or asset. The language for this type of provision is as follows: "I give, bequeath, and devise (dollar amount or description of gift) to Cancer Support Community Valley/Ventura/Santa Barbara or its successor, now or formerly at 530 Hampshire Road Westlake Village, 91361 in the State of California, to be used for its general purposes."

#### Other Ways to Support Cancer Support Community Valley/Ventura/Santa Barbara

Naming CSCVVSB as a beneficiary of a **retirement plan** or **life insurance policy** is another way to provide financial assistance to continue to support those who are impacted by cancer and their loved ones. You may also choose to name CSCVVSB as a beneficiary for your bank accounts. Lastly, **Life income gifts** such as charitable gift annuities and trusts are also a great way to support CSCVVSB.
